Thank you for your interest regarding slip rental at the Alpine Boat Basin. In order to be placed on our waiting list, kindly fill out the attached application and return it to our mailing address along with the rental contract. We ask that you fill out all information accurately and be sure to sign the contract. Please provide the hull length shown on your registration as this is the number we use to calculate your rate.

Once we have an opening, we will contact you and advise you of your slip assignment. At that point you will need to make payment in full and provide a copy of your registration and insurance within seven calendar days of receiving notice. Once we have all of the documentation and payment, you will receive a copy of your signed contract, gate key, parking decal and Guest Parking Permit.

Alpine Boat Basin Slip Rental Contract

This **CONTRACT** is made between **PALISADES INTERSTATE PARK COMMISSION**, a joint corporate municipal instrument of the States of New Jersey and New York (hereinafter call the “**Commission**”) and the owner (hereinafter called the “**Lessee**”) whose name and signature appear on the application.

The Commission and the Lessee agree to the following conditions:

FIRST: Commission agrees to lease a slip in Alpine Boat Basin for the season beginning May 1 and ending October 31 of the current year to the owner(s) listed on the application for the particular boat indicated on the application. Should said boat be sold during the season, the owner(s) shall notify the Commission of the sale and shall relinquish all rights to said slip unless a new boat is purchased and the proper paperwork is furnished to the Commission. Under no circumstances can the new owner(s) of the sold boat occupy or use the slip without the express consent of the Commission.

SECOND: Lessee agrees to provide proof of ownership, in the form of current boat registration, and proof of insurance for the boat that will occupy the slip, at the start of the boating season. Failure to furnish said proofs, which must be in the name of the lessee, shall give the Commission the right to cancel or refuse to renew this Contract. Lessee further agrees to provide current and valid contact information in the form of phone numbers, email addresses and street addresses as indicated on the rental application and renewal form.

THIRD: Lessee agrees to abide by the complete Rules and Regulations of the Commission and the Boat Basin Regulations, a copy of which is attached to this Contract. A copy of these regulations will also be posted at the Boat Basin. Lessee further agrees that failure to abide by said regulations in any detail whatsoever shall be sufficient cause for revocation of this Contract, loss of the slip leased hereunder, loss of any payments made in connection with leasing of the slip, and loss of any and all privileges pertaining hereto. Lessee agrees that neither the Commission, collectively and individually, nor its agents and/or employees be liable in any manner for any damages from such revocation. Revocation shall be effective on ten (10) days written notice to the owner at the address listed on this Contract.

FOURTH: Lessee agrees that neither the Commission, collectively and individually, nor its agents and/or employees be liable for any damage, loss, destruction, or deterioration of or to said boat or to any article or thing attached thereto or left thereon or the contents thereof from any cause whatsoever, lessee agrees that neither the Commission, collectively and individually, nor its agents/employees be liable for any personal injuries sustained by lessee or any other person as a result of or in connection with the performance of any of the services provided for herein, whether such injuries be due to the negligence of the Commission, collectively and individually, or its agents/employees. Lessee agrees to indemnify and save harmless the Commission, collectively and individually, its agents/employees from any loss, damage, or expense incurred by reason of any such damage, loss, destruction, or deterioration as aforesaid or by reason of any such personal injuries sustained by the lessee or any other person as aforesaid.

FIFTH: Lessee agrees to and shall save, hold, keep harmless, and indemnify the Commission, collectively and individually, its agents/employees from and for any and all payments, expenses, costs, and attorney fees from and for any and all claims and liability for losses or damage to property or injuries to persons occasioned wholly or in part by or resulting from any acts or omissions by the lessee or the lessee’s agents, employees, guests, licensees, invitees, assigns, or successors or for any cause or reason whatsoever arising out of or by reason of the occupancy by the lessee.

The Commission for itself and its successors and the lessee for himself, his successors, executors, administrators, and assigns, hereby agree to the full performance of the covenants herein contained. This contract shall be in effect for the duration of lessee’s assignment in the Alpine Boat Basin.

In witness whereof, Palisades Interstate Park Commission has caused these presents to be signed by their Superintendent, Assistant Superintendent, or authorized representative and the Lessee has hereunto set his hand.
